Child Care Tuition Scholarship Program



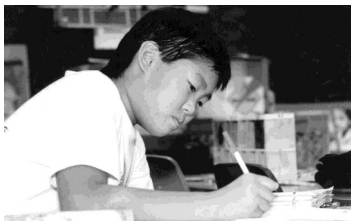
What Does This Program Have to Offer?

The Child Care Tuition Scholarship Program can provide:

- Funds to pay for part of the child care tuition for children ages 6 weeks to 12 years or 21 years if child has special needs
- Counseling and referrals regarding quality child care options
- Access to programs that are licensed and/or registered.
- Free parent education sessions

Please Note:

- Funds are limited
- Scholarship recipients will be selected by lottery



How Do I Qualify For The Scholarship?

In order to qualify for the Child Care Tuition Scholarship Program, the applicant must meet the following eligibility requirements.

- Reside in Rockland County
- Have a child currently enrolled in a licensed/registered child care program **or** be seeking enrollment in child care
- Not be eligible for DSS child care subsidy
- Meet the income eligibility guidelines below:

Family Size	Income Eligible (Income does not exceed)
2	\$44,055
3	\$55,440
4	\$66,825
5	\$78,210
6*	\$89,595

*For larger families add 11,440 for each additional family member yearly.

Please be aware that income eligibility requirements are subject to change
