## Using Data for Good

These days, data management is vital for organizations. Collecting, protecting, analyzing, and using data to inform decision-making leads to improved service delivery, efficiencies, and cost savings. This is especially important for nonprofits. But where do we find the time, money, and expertise to help us effectively understand data management systems? When CCRR learned of a pro-bono opportunity to address our data management needs earlier this year, we jumped at the chance! Through [VolunteerNY!](#) and the [Taproot Foundation](#), we connected with Westchester-based pharmaceutical company [Regeneron](#). Its *Using Data for Good* program links Regeneron employees with nonprofits to identify organizational and data needs and develop practical solutions.

In our case, after a couple of introductory meetings, we worked with members of the Regeneron team to identify and understand our needs. A scope of work was developed focusing on our professional development training and event registration; PreK administration; child care site visit forms; and stakeholder surveys. The team will also help address some of our hardware needs and will provide recommendations for near-term, mid-term, and long-term hardware and software solutions.

We have already begun testing some near-term solutions and expect to fully implement them in the fall. Ultimately, systems that give us a clearer understanding of need and create efficiencies will free up time spent creating and managing paper reports and enable us to focus on enhancing the lives of all children by helping families access quality child care, helping programs deliver quality child care, and advocating for smart early childhood policies and investment.

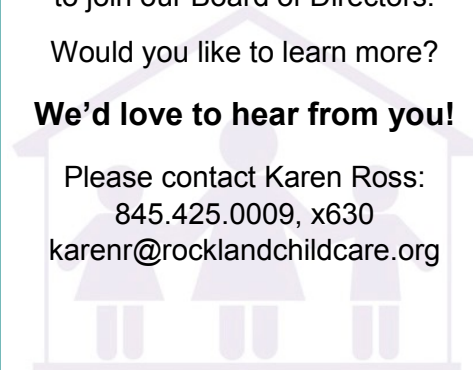

## 2019-2020 Pre-K Update

**CCRR ADMINISTERS PREK SERVICES FOR THE FOLLOWING ROCKLAND COUNTY SCHOOL DISTRICTS:** Clarkstown, Nanuet, North Rockland, Nyack, Pearl River, South Orangetown, and Suffern Central.

A lottery was conducted for each school district mid-April by several Board members—none of which had a child eligible for PreK. All seven school district slots are full for the 2019-2020 school year. There were 255 children on the wait list as of late June.

**PREK STAFF WILL KICK-OFF THE NEW SCHOOL YEAR BY ATTENDING A SELECTION OF FULL DAY PROFESSIONAL DEVELOPMENT SEMINARS IN THE AREAS OF SCREENING, ASSESSMENT, AND CURRICULUM DEVELOPMENT.**





Jawonio's early childhood education program was selected for the **Sodium Reduction in Communities Grant**. This grant provided multiple training opportunities for program staff and parents. During the grant's third year, an exciting hands-on opportunity was offered: *Sodium Reduction Program Food Service Training* hosted by Rockland Community College's Culinary Center in Nyack, NY. Participants prepared vinaigrettes, marinara sauce, and vegetarian chili from recipes that included salt substitutes and alternatives.

CCRR's nurse, Kristin G. Saunders, RN, BSN, worked with Jawonio to review and revise their nutrition policy. Jawonio was able to tailor its menus in order to meet low sodium requirements. The policy was shared with parents/guardians and staff so that sodium reduction can be accomplished not only in the program but at home as well.

## In the kitchen with THE SODIUM SLEUTH



Child Care Resources of Rockland is working collaboratively with the Rockland County Department of Health through a grant offering sodium reduction training and technical assistance to child care centers. We met up with Donna Perreca, the cook for Jawonio's School Age Care program.

Donna found CCRR's sodium reduction training to be very informative and said the low sodium tips and herbal alternatives she learned have been very useful in planning meals for the children.

Donna is fully committed to preparing low-sodium meals and enjoys discovering recipes that are healthy and good tasting— hence the moniker, Sodium Sleuth.

Donna shared, "It is important to curb salt intake in the early years of life as children are developing their palates. I have a family history of high blood pressure, so providing low-sodium meals to the children is personally important to me." In addition to cooking healthy meals for the children, Donna is also passionate about promoting the benefits of a low-sodium diet to her colleagues.





## Nurse's Notes LEGAL BEAGLE EDITION:

### New Immunization Law: *Removal of Non-Medical Exemptions*

Effective **June 13, 2019**, there is no longer a religious exemption to vaccination requirements for children to attend child day care settings and/or public, private or parochial schools. Children who had a religious exemption in the past will now need to receive the first age appropriate dose in each required immunization series in order to attend or remain in child care or in school.

The required immunizations for child care and/or school entrance are: DTaP (Diphtheria, Tetanus, and Pertussis), Polio, Hepatitis B, Haemophilus influenzae type B (Hib), Pneumococcal Conjugate (PCV), Varicella (Chicken Pox), and Measles, Mumps and Rubella (MMR). The deadline for the above requirement was **June 28, 2019**.

By **July 14, 2019**, parent(s)/guardian(s) are required to show that they have scheduled appointments for all required follow-up doses. These requirements apply to summer child child care programs as well. OCFS regulates licensed child care programs in the state and all programs must be in compliance with the law. OCFS may sanction programs which do not comply with the law.

If your child will be attending Pre-K in September, please be advised that the deadline for obtaining the first dose in each required vaccinations series is **14 days** from the first day of school or enrollment in child care. However, the New York State Education Department strongly advises that parent(s)/guardian(s) obtain these vaccinations for their children as soon as possible.

Parent(s)/guardian(s) must show that they have scheduled appointments for all required follow-up doses within **30 days** of the first day of school.

The new legislation does **NOT** affect valid medical exemptions. In order to obtain a valid medical exemption:

- It **MUST** be documented either on Form 5077 issued by the NYS Department of Health (form is available on its website) or on a signed statement that certifies the immunization may be detrimental to a child's health
- It **MUST** be signed by a physician licensed to practice medicine in New York State
- It **MUST** contain sufficient information to identify the medical contraindication to a specific immunization.
- It **MUST** be confirmed annually

If you are a child care provider, please strongly advise parent(s)/guardian(s) to contact their pediatrician offices as soon as possible to schedule appointments. They must adhere to the current law to ensure admittance to child care and/or to Pre-K.

Parent(s)/guardian(s) who have immunization questions, should contact their health care provider.

## Advance your career! **Child Development Associate™ (CDA)**

The CDA credential is the most widely recognized credential in early childhood education and the best first step on the path of career advancement in Early Childhood Education! The purpose of the CDA is to promote, support, and enhance the health and safety of all children from birth to 5 years of age.

On June 27, 2019, CCRR began a new Child Development Associate™ (CDA) course with 15 students who are pursuing the CDA Credential in Infants and Toddlers, Preschool, and Home-Based Family/Group Family Child Care. CDA requires 120 hours of training, a verification visit, and a written test at the end of the course.

## The Importance of Outdoor Play

During the first few years of life, infants and toddlers are trying to make sense of the world around them through their own experiences. During these experiences infants and toddlers are soaking in every sound and movement. They take in information and try to process it into ideas of how the world works.

Outdoor experiences are not only enjoyable, they are crucial for infant and toddler cognitive development. Outdoor play promotes early language development by providing a rich sensory experience. The knowledge babies gain by being outdoors provides a foundation for literacy and science learning. As teachers or child care providers, it's important to create an environment to help promote physical and social development.

While outdoors, infants and toddlers require constant supervision during exploration, as well as surfaces that will allow them to explore and move freely with ease. Infants explore their world partially by putting objects in their mouths. It is necessary to inspect the area for potential choking hazards, unsafe materials, and a safe accessible surface. Keep in mind infants are learning to crawl and toddlers are learning to walk; they're mastering the art of balance and spatial awareness. Providing a safe area where caregivers are in close proximity to the children is extremely important. An adult should always be nearby to monitor the child's movements and to prevent an injury. Outdoor play has a multitude of benefits and aids in a child's development. It promotes executive function (skills

used to help plan, negotiate, collaborate, and exposure to trial and error), while sun exposure helps create vitamin D which plays an essential role in bone development and to the immune system. Not only does it promote physical health, it assists in improving sleeping habits. Outdoor play also creates opportunities for social interaction for the children and anchors them to the real world. Playing outdoors with the children is fun for adults, too!

## Gross Motor Technical Assistance

*Young children learn the most when they are actively interacting with other people and manipulating objects in their environment.*

*(Kamii & DeVries, 1978; Piaget, 1952)*

Interaction Child Care was one of the child care programs participating in a technical assistance program we offered with funding allocated in our contract with the NYS Office of Family and Children Services.

CCRR's Quality Enhancement Specialists provided 10 hours of technical assistance program in gross motor play to six child care programs. They guided the teachers through a variety of age appropriate physical activities by explaining how early toddlers through preschoolers could use these activities.

*Bubble Wrap Jumping* is played by adhering bubble wrap (at least 10 feet in length and 24 inches wide) to the floor with tape. Older children are guided to jump along the bubble wrap to music or specific instructions from the teacher while younger children are guided to crawl along the wrap for a sensory experience.

## NUTRITION CORNER

**VEGETABLE SOUP**—Here is a recipe for an easy and delicious soup you make with children and enjoy on a chilly autumn day. Follow recipe exactly, use your preferred vegetables, or any you have on hand.

### INGREDIENTS

2 tablespoons olive oil  
 1 medium yellow onion, chopped  
 3 carrots, chopped  
 2 celery ribs, chopped  
 5 cloves garlic, minced  
 1 red bell pepper, chopped  
 1 medium zucchini, chopped  
 6 Yukon gold potatoes, chopped (about 2 cups)  
 3 (14.5 oz) cans vegetable broth  
 1 (28 oz can) diced tomatoes  
 1/2 tsp dried thyme  
 1/2 tsp dried basil  
 1/4 tsp black pepper  
 1 1/2 cups frozen green beans  
 1 cup frozen corn  
 1 cup frozen peas

### DIRECTIONS

In a large pot, heat olive oil over medium high heat. Add onion, carrot, and celery and cook for 5 minutes or until vegetables are tender. Add garlic, red pepper, zucchini, and potatoes. Cook for 3 minutes.

Add the broth, tomatoes, thyme, basil, and pepper. Reduce heat to medium-low, cover and simmer for 25-30 minutes, or until the potatoes are soft.

Stir in the green beans, corn, and peas and cook for another 5-7 minutes, or until vegetables are cooked through.

Serves 10.
