# What Does This Program Have to Offer?

## How Do I Qualify For The Scholarship?

In order to qualify for the Child Care Tuition Scholarship Program, the applicant must meet the following eligibility requirements:

- Reside in Rockland County
- Have a child currently enrolled in a licensed/registered child care program **or** be seeking enrollment in child care
- Not be eligible for DSS child care subsidy
- Meet the income eligibility guidelines below:

Family Size	Income Eligible (Income does not exceed)
2	\$61,230.60
3	\$77,190.30
4	\$93,150.00
5	\$109,109.70
6*	\$125,069.40

\*For larger families add \$15,959.70 for each additional family member yearly.

Please be aware that income eligibility requirements are subject to change
